



NEIL KEENAN UPDATE | They Are All Watching You: 'Malaysia'

I'm coming on now to show you the next attack. Today is the sixth of February 2016. And my name is Neil Keenan and I'm going to bring you the latest, it really is the latest with relation to the targeting of Malaysia. Malaysia is being targeted right now by the cabal. And on the ninth this month, there will be an agreement signed between the banks, Malaysia and someone else, which will basically destroy the Malaysian economy in a short period of time when the U.S. dollar flattens up.

But I'll tell you the story. You know, we know that Indonesia's under attack, some are on attack right now. But there is an attack taking place in Southeast Asia as I sit here talking to you. And involving Malaysia. It's involving the Prime Minister, Najib Razak, who is actually a decent man and there's money missing in the accounts somewhere and there's some money that's been borrowed. And some money given by the Petro Saudi group and there's all kinds of things happening which you've been reading about and it all goes back to allegedly the Prime Minister and his group.

There's a new AG (Attorney General) in Malaysia who says "no, there's no wrongdoing." There's others who say "yes there is because the money hasn't been given back." And it seems to me like there's two different parties that are fighting each other. One wants to leave and the other wants to stay. I mean I really don't know what's going on at the moment, but that's really not the key, I think, to the whole thing. You see there is a little bit of money, what was it? \$61 million, I believe it was \$61 million. We can look at that again, but that's not really the key. \$620 million, apparently.

It went into his personal account, by the way, not to his corporate account, this Malaysian bank account, building account. It's going into a personal account. The

money made seven stops before it finally got to the bank where they thought it should be in Singapore. Little did they know that the entire world was watching the moving of the funds and it's unusual. And the red flags went up.

And they froze the \$621 million, which caused another problem because now the Prime Minister and his team didn't have the money to pay for the missing funds. So they had to find another way to get the funds to compensate for what's missing, and which shouldn't have been missing at all. But it was and it still is. And this is about the Prime Minister of Malaysia, who's really caught in the middle of some real crap that's going on in his country between parties, people.

Najib Razak, the Prime Minister--everybody that's called me and spoken to me and given me information says he's a good guy. He's a decent person. So I really don't want to go out of my way to malign him and I really don't know all the story. But I know you should read the story for yourself and Google, and you'll see it up to a certain point. But after that certain point where things change, you can't get that anywhere because it hasn't happened yet. And people don't know about it yet. I do, I know and I don't think many people know, I do. And now you will. I'll make sure you will. And I hope that Malaysia and I hope the Prime Minister and the Attorney General and the people all listen, because if we don't do this carefully, then Malaysia is going to just flatten right out in just a short period of time because their economy is going to pop and bubble and go bye bye. And somebody, a few people are going to make fortunes at the grief of the Malaysian people.

I like the Malaysian people. They're good people. Just like Indonesia--great people, they're warm, humble, kind. Not all of them honest, but then again, anywhere you go.

So let me tell you the story about the Prime Minister, Mr. Razak. Apparently his party borrowed some money or took some money from another division, a part of the government itself and used it for some reason, for whatsoever, whatever it may be. And then they get the money back to repay the missing money from the Petronas Saudi, or Saudi Petronas and the money was sent, \$621 million to numerous banks, made stops in many, many places and finally stopped in Singapore.

By the time it got to Singapore, after stopping at eight places, all the red flags in the world had gone up. Everybody was waiting for the money, the CIA, Switzerland, everybody--waiting to see what was going to happen, including the Malaysian government. The Attorney General's office investigated the divisions and so on.

Well as soon as it got to Singapore it was frozen, because the Singaporeans also wanted to know if the money was legitimate so that they could place it in their accounts. So that's where it lies today, the money, from what I understand.

In the meantime, when they froze that money, that eliminated the possibility of placing the money back into that account, where the money was borrowed from and was missing. So he ended up between a rock and a hard place, with the money being tied up in Singapore. That's not a good thing. Now they need that money again and where do you get it in a world with thieves, right? And they have to find it.

So who comes out of nowhere, out of nowhere? Bongbong Marcos, President Marcos' son, second son, the second oldest son, not the first. Most people think that he's the first. The first son is Louis Reyes. I've spoken to him in the past, when we were having trouble with the Philippines and he was worried about his life. He had to get out. He lives in Canada, I believe now.

So Bongbong had an account in an off shore bank of \$14 trillion cash account. And he offered to exchange it to the Prime Minister, to the banks, for a 4.5 Riggitt return. Riggitt is the money in Malaysia. 4.5 Riggits per dollar. That was the deal that's been worked out apparently. And that's a lot of Riggits, with 30% coming back to the government. So it sounds like a good deal, right? Sounds great, you got money, trillions of dollars. You've got the dollar stronger than the Riggitt. So you know the Riggitt will go down and the Dollar will go up. But that's not the case here. Because the case here, and Mr. Marcos knows it, and I know it, and many others know it. The dollar is going to die. And when the dollar dies, it's really going to be the end of Malaysia, because they're going to be caught holding dollars, not their own currency. They'll go broke. The people that live there will have many reasons to scream and shout and there's no reason for it to get that far, not at all. You're missing some money there, Mr. Razak.

You have to wait a little longer, I think, because if you make a move now, if you do, you're going to go to jail. Your Attorney General might go to jail, your banks may go to jail, some of your banks. What you don't understand is that many people are watching you now. The money that went into the, that was used to bring in that money into the offshore bank, you have to wonder who that money belongs to that was used. It wasn't Mr. Marcos' money. It was someone else's. I'm sure Mr. Marcos doesn't want a problem either.

I mean, if I don't do this now and put this out here like this, then on Tuesday or Wednesday you may be under arrest. The bankers, yourselves. And I think doing it like this--I don't think any of you are trying to do something illegal. I think you're trying to do a deal, but in the end you're talking about the destruction of Malaysia. Because when those dollars go caput, which they're going to go caput, then they're going to be left holding nothing.

And the 30% we're talking about really is for personal benefit. Personal gains, not for the government of Malaysia. So I think you should wait for another day, another time, when finally I sign those papers. You know I'm going to be assisting

Indonesia. Indonesia is first and foremost. And then there's others that are already talking to me about help through the accounts, many. Because you know I won't forget you. And I think that the East should be taken care as well as parts the West. But the East deserves a big break, because they've been stolen from for so long.

So I think you should wait, because you're being watched. I can only tell you what I know. You've got satellites looking at you. You have lots of things happening that you don't know, in both places, in the Philippines, as well as well as the offshore banking, as well as the banks. I'm in a good spot here and I think this is the best information I could ever give you is to tell you to back off. It can't help you with your own picture. It will hurt the Malaysian people too. I don't want to see that happen either.

Now that's really all I can tell you is to walk very softly. Don't make any mistakes and go back to your lives, normal lives. And don't think about what could be when it's going to backfire on you and it's already being planned to backfire on you. Be careful.

Now, you're not the only person they've made plans for. They're setting up Indonesia. I won't let it happen to Indonesia. I've got some fantastic friends in Indonesia and I don't want them getting hurt, the government, nor them. And I'll stick my nose in there to protect them. And that's what I'll do. In your case I don't know you so well but I do know from my visit to Kuala Lumpur that you've got very nice people, similar to Indonesia, very warm, kind, gentle, intelligent.

So I'm not going to say anything more than that, other than they're watching you. Okay? Back off. Now if you want to reach me, there are ways you can reach me.

You know I can't believe that this is happening before my eyes. Every time I watch television or look at the internet I see that Obama is doing something stupid again. But everything he's doing he's doing in such a way that we don't really have time to react, going from one to the next. I mean it's pretty crazy what he's doing--opening up the borders, telling the Border Patrol "don't hold them, let them go". Governor Brown over in California is telling everybody that they can vote.
